Principals

Middle School

Mr. Clawson complimented the technology department for keeping the district up to date with the newest technology.

Food Service

In the absence of Sarah Smith, Director, Mr. Clawson reported on the average of 30 Breakfast to Go meals are being served at the high school. The meals are free to students however the district will receive reimbursement from the state for each meal served. Ms. Smith will be ordering commodities for the next school year in February or March. A report on the tower gardens revealed 85 gallons of lettuce, 70 cherry tomatoes and 1 cucumber have been harvested for campus meals.

Athletics

Andy Howard, Director, reported 73 girls and 98 boys are involved in spring sports. Basketball continues with the girls 2-7 in district and the boys 3-4 in district. Coach Howard announced the football players who received awards. Nathan Aguirre has been nominated to play in the FCA football game. He complemented and thanked his coaching staff for their service and dedication to the athletes and their students in the classroom.
