 3. Considering the appointment, employment, evaluation, reassignment duties, discipline, or dismissal of a public officer or employee or to hear complaints of charges against a public officer or employee, unless such officer or employee requests a public hearing. Sec. 551.074
 4. Conference with employees to receive information. Sec. 551.075
 5. Considering discipline of a public school child or children, unless an open hearing is requested in writing by a parent or guardian of the child. Sec. 551.082
 6. Considering the deployment, or specific occasions for implementation, of security personnel or devices. Sec. 551.076
 7. Considering the standards, guidelines, terms or conditions the board will follow, or will instruct its representatives to follow, in consultation with representatives of employee groups in connection with consultation agreements provided for by Section 13.901 of the Texas Education Code. Sec. 551.083
 8. To discuss or adopt individual assessment instruments or assessment instrument items. Education Code 39.030 (a)
 9. Negotiations for economic development. Sec. 551.086
- All final votes, actions, or decisions shall be taken or made in open session.
