Notice is hereby given that the Brady Independent School District will convene in special session on the **14th day of November, 2011, at 5:00 p.m.**, to receive public comment on redistricting of school board districts. Following the public hearing, the school board will take up for consideration and possible action one or more alternative plans for the redistricting of school board districts. The Brady School Board reserves the right to take any and all appropriate action regarding the redistricting of the school board's political boundaries, including the acceptance of new boundaries for the school board districts, modification of any boundaries, and/or tabling the pending proposals for later consideration and/or action.

The Public is invited to attend and participate in this meeting. Those wishing to address the Board should sign a speakers request form provided for this purpose. Each speaker will be asked to come before the board, to identify themselves, their address, and the district they reside within. Comments should be reasonably concise and to the point. Questions will be answered but the board will not permit argument or excessive discussion of any particular topic. The hearing will be conducted under rules of judicial decorum. A tape recording of the hearing will be made of this hearing. Your comments will be transcribed and included with the submission of the proposed changes to existing school board districts to the United States Department of Justice.

| Section 551.072 | For the purpose of discussing the purchase, exchange, lease, or value of real property and negotiated contracts for prospective gifts or donations. |
| Section 551.074 | For the purpose of considering the appointment, employment, evaluation, reassignment, duties, discipline, or dismissal of a public officer or employee or to hear complaints or charges against a public officer or employee. |
| Section 551.082 | For the purpose of considering discipline of a public school child or children. |
| Section 551.076 | To consider the deployment, or specific occasions for implementation, of security personnel or devices. |
| Section 551.083 | For the purpose of considering the standards, guidelines, terms or conditions the Board will follow, or will instruct its representative to follow, in consultation with representatives of employee groups in connection with consultation agreements provided for by Texas Government Code Chapter 551. |
| Section 551.084 | Excluding witnesses from a hearing. |

Should any final action , final decision, or final vote be required in the opinion of the Board with regard to any matter considered in such closed or executive meeting or session, then such final action, final decision, or final vote shall be at either:

- a. the open meeting covered by this notice upon the reconvening of this public meeting, or
- b. at a subsequent public meeting of the Board upon notice thereof; as the Board shall determine.
