2022-2023** Mr. Bierman moved to adopt the resolution setting the minimum fund balance for the 2022-2023 school year to maintain a yearly fund balance in the general operating fund in which the total fund balance is three (3) months operating expenditures and the unreserved, undesignated, unassigned fund balance is three (3) months operating expense of the total operating expenditures per recommendation by Hector Martinez, Superintendent, seconded by Mr. Enger and the motion carried 4-0.

ADOPT RESOLUTION DESIGNATE FUND BALANCE 2021-2022 Mr. Enger moved to commit \$150,000 of the August 29, 2022, General Fund unassigned fund balance for the 2021-2022 school year for vehicle use and \$100,000 for safety and security use per recommendation by Dr. Martinez, seconded by Mr. Bierman and the motion carried 4-0.

PUBLIC HEARING PROPOSED 2022-2023 BUDGET The public hearing for the proposed 2022-2023 District budget began at 12:14 p.m. Dr. Hector Martinez, Superintendent, and Barbara Landry, Business Manager, presented the 2022-2023 proposed budget. Dr. Martinez was pleased to announce the proposed budget is balanced. The total budget proposed is \$200,000 less than last year. The public hearing ended at 12:16 p.m.

ADOPT OFFICIAL DISTRICT BUDGET FOR 2022-2023 Mr. Huffman moved to adopt the official District budget for the 2022-2023 school year for Operating Fund 199, Child Nutrition Fund 240, and Debt Service Fund 599 per recommendation by Dr. Martinez, seconded by Mr. Bierman and the motion carried 4-0.

PUBLIC HEARING 2022-2023 PROPOSED M&O AND I&S TAX RATE

The public hearing regarding the proposed 2022-2023 Maintenance/Operations tax rate and the Interest/Sinking tax rate began at 12:17 p.m. Dr. Martinez explained the M/O tax rate is set by the Comptroller’s Office which this year was \$.8046 plus the 5 pennies the district is capable of adding making the total \$.8546. The I&S tax rate is set by the County Appraisal District’s office and that figure is \$.29068. This makes a total tax rate of \$1.14528. The public hearing ended at 12:20 p.m.

ADOPT DISTRICT OFFICIAL M&O AND I&S TAX RATE FOR 2022-2023

Mr. Bierman moved to adopt the Maintenance & Operations (M&O) tax rate for the 2022-2023 school year at \$0.8546 per \$100 valuation and the Interest & Sinking (I&S) tax rate for the 2022-2023 school year at \$0.29068 per \$100 valuation for a total tax rate of \$1.14528 per recommendation by Dr. Martinez, seconded by Mr. Enger and the motion carried 4-0.
